## 5. Fire-fighting measures

### Extinguishing media

If aerosol cans are ruptured, care should be taken due to the rapid escape of the pressurized contents and propellant. Vapors may form explosive mixtures with air.

### Advice for firefighters

**Protective actions during firefighting** Avoid breathing fire gases or vapors. Evacuate area.
